- a. New Graduate Student Dismissal Appeals Procedure

Currently no formal dismissal appeals process for students at the graduate level. After discussion of proposed process, Georgia Tsouvola moved to approve new procedure, Nweze Nnakwe seconded. All approved.

Procedure for Appeal of Dismissal from a Graduate Program

Students who are dismissed from a graduate program can use this appeal procedure. If a student is dismissed from more than one program at the same time, they must appeal each dismissal separately.

- i. To appeal a dismissal from their graduate program a student must submit a written letter to the College Dean or designee within 5 business days from the date of the dismissal letter. The written appeal letter should clearly outline the reason for the appeal the facts and circumstances leading to the dismissal, and a written plan with benchmarks to continue successfully in the graduate program.
- ii. Upon receipt of the appeal, the College Dean or designee will notify the School Director/Department Chair that issued the dismissal, Graduate Program Coordinator, registrar's office, and Director of the Graduate School. The student, graduate program coordinator, and/or any other individuals that may be of assistance in the review of the appeal can be interviewed or asked to provide further written information. The intention of this step in the process is to be thorough, but timely with a response.
- iii. The student will maintain course enrollment until a decision on the appeal is reached.
- iv. After considering all available information, the College Dean will provide a written response to the student on the decision of the appeal.
- v. If the dismissal is upheld, the student will be dropped from enrolled courses and become inactive.

If the dismissal is overturned, the student will remain in the program and any required benchmarks for continued enrollment will be communicated in writing.

b. Graduate Certificates

The Illinois Board of Higher Education (IBHE) no longer requires a specific number of hours to complete a graduate certificate program. Graduate School policy currently states, "A minimum of 9 semester hours but no more than 17 hours beyond the bachelor's degree is required to complete a post-baccalaureate certificate" and "A minimum of 24 semester hours of coursework beyond the master's degree but fewer than a doctoral degree is required to complete a post-master's certificate program".

Council discussed amending the policy to a blanket statement covering all certificates, "A minimum of 9 semester hours is required to complete a Graduate Certificate". Plus, both types will be referred to collectively as, "Graduate Certificates". The two types will continue to be used by IBHE, the Curriculum Forms system, on transcripts, in the Graduate Catalog, and by Admissions.

Kim Astroth moved to approve amending the policy and the reference to certificates. Emily Jones seconded. All approved.

c. Standing hours for Doctoral Professional Programs

Members discussed the sharing of 24 credit hours from a master's program to a professional doctoral program. This will reduce credit hours required for completion due to overlap of the same courses required for both degrees. Only applies to courses completed within 5 years of admission to the professional doctoral program. Sharing of hours only applies to professional doctoral programs. Doctoral research programs, master's programs and graduate certificates are not eligible.

A motion was made by Kim Astroth for this to become policy. Cherrill Stockmann seconded. All approved.

d. Task force on Graduate School

Provost recommended university-wide focus meetings and open forums regarding the future of Graduate School. A task force is being formed.
