- a. Review of Residency Requirement for Doctoral Programs
 - i. Purposes of doctoral residency:
To orient and prepare graduate students to meet academic expectations and engage in activities that are associated with involvement in a scholarly environment within a community of scholars as they pursue their doctoral degree.

To engage and stimulate the intellectual, personal, and social development of graduate students in the process of inquiry.

 - ii. All doctoral coordinators contacted. Agreed residency no longer necessary requirement...established over 40 years ago. Will not hinder time to degree. If removed, Accreditation not a problem per

Provost Office and Higher Learning Commission. No objection from Council if removal from catalog is indicated.

New Business

- a. COVID-19 and Graduate Education
 - i. Pass/No Pass (P/NP) Grading
 - a. President Dietz approved P/NP as a grading option for all classes in spring semester 2020 based on the decision to move all classes online due to the pandemic.
 - b. Graduate students allowed maximum of 12 hours of P/NP grades. A grade of "B" required to pass graduate level courses including accelerated/integrated courses for graduate credit.
 - c. Deadline May 4 to choose P/NP option in My Illinois State. Deadline to change from grade to P/NP or P/NP to a grade May 14-18. Registrar's Office will make changes.
 - ii. Alternative assignments
 - a. Alternative or online assignments allowed for students required to complete, a non-licensure internship, if they are not allowed onsite or cannot go to the site.
 - iii. Online recruitment
 - a. Rachel Caracci happy to work with graduate coordinators on virtual information sessions.
 - iv. Preparations for Fall
 - a. Task force in charge of logistics for fall semester. Need to be prepared for classes starting face to face and changing to online or online from the start. Social distancing guidelines will most likely be in place. What type of accommodations for large class sizes?
